# **ACTION CALENDAR (Items 5 through 14)**

 Consider Modified Scope and Eight-Month Term Extension by Premium Transportation Services, Inc. dba Total Transportation Services (TTSI), Contract #MS21015 (\$1,500,000 – Deploy 15 Near-Zero Emission Trucks) Ravenstein

Due to the unavailability of trucks from Freightliner in a timely fashion, TTSI requests to substitute the use of Volvo VNL64T300 and Mack Anthem 64T trucks instead, at no additional cost to the MSRC. TTSI further requests an initial contract term extension to January 2, 2022—approximately an eight-month term extension. The MSRC Contracts Administrator recommends approval.

6. Consider 22-Month Term Extension by City of Laguna Woods, Contract #ML18094 (\$50,000 – Install Two Level II EV Chargers)

Ravenstein

The City planned to complete the installation of the separate City Hall/Public Library Project before installing the EV charging stations. The City Hall/Public Library Project experienced several delays, which had a cascading effect on the EV station project. The City identified an opportunity to complete the work for the stations concurrent with the larger project and now anticipates they will be operational by September 2023. The City requests an initial 22-month term extension. The MSRC Contracts Administrator recommends approval.

7. Consider One-Year Term Extension by City of Gardena, Contract #MS18027 (\$365,000 – Install Limited-Access CNG Station, Modify Maintenance Facility and Train Technicians)

Ravenstein

The City indicates that design changes have delayed the project for several months. Also, supply chain delays—especially pertaining to the CNG station's switchgear box, have further delayed progress. Having previously received a 16-month extension, the City is requesting a one-year term extension. The MSRC Contracts Administrator recommends approval.

8. Consider 6-Month Extension by Southern California Association of Governments (SCAG), Contract #MS18015 (\$2,000,000 – Future Communities Partnership Program)

Ravenstein

Having previously received extensions totaling 27 months, SCAG requests a 6-month term extension. The pilot in Los Angeles has encountered an obstacle with recruiting pilot participants, and additional time is needed to incorporate and implement new strategies which have been identified. Additionally, the pilot in Anaheim has been impacted by the dissolution of the company which managed a key mobile application. While necessary reconfigurations have been accomplished, this delayed the project. The MSRC Contracts Administrator recommends approval, contingent on this being the final extension.

 Assess Progress and Consider Reduced Scope and Value by San Bernardino County Transportation Authority (SBCTA), Contract #MS14072 (\$1,250,000 – Implement Various Signal Synchronization Projects) Ravenstein

SBCTA indicates that one of their project partners, the City of Yucaipa, has been unable to install fiber optic cable in a segment of the project area. However, the Traffic Signal Interconnect System which the fiber optic cable was intended to support will still be able to function as originally designed due to a wireless connection. SBCTA requests to remove the requirement to install the fiber optic in this segment, with a corresponding reduction in contract value from \$1,250,000 to \$1,237,500 as part of the FYs 2012-14 Traffic Signal Coordination CTC Partnership Program. As part of considering this request, the MSRC needs to evaluate whether the contingency associated with the previous term extension has been met.

10. Modified Statement of Work and One-Year Term Extension by Riverside County Transportation Commission (RCTC), Contract #MS18024 (\$1,500,000 – Implement Vanpool Incentive Program)

Ravenstein

RCTC requests two modifications to the Statement of Work: 1) Vanpool is currently defined as "five to fifteen Eligible Commuters commuting on a regular basis...", and RCTC requests to modify the definition to "four to fifteen Eligible Commuters..."; and 2) the contract specifies that vanpool incentives shall not exceed \$400 per vanpool per month, but RCTC desires the latitude to increase incentives up to \$600 per month using non-MSRC funds. Additionally, having previously receiving extensions totaling two years, RCTC is requesting a one-year term extension to maximize and amplify the use of the contract allocation to attract more vanpoolers. This contract was previously extended a total of two years. The MSRC Contracts Administrator recommends approval of the requested modifications to the Statement of Work but recommends against granting the requested term extension. Alternatively, if the MSRC does desire to grant the extension, the MSRC Contracts Administrator recommends that the contract value be reduced by \$171,500.

 Consider Change of Station Locations and 18-Month Term Extension by City of Yucaipa, Contract #ML18129 (\$63,097 – Install EV Charging Infrastructure) Ravenstein

The City of Yucaipa requests MSRC review of an 18-month term extension request which has been denied by the MSRC Contracts Administrator. The City indicates that the funding priorities of their intended funding partners shifted, forcing them to seek new potential partners and delaying project completion. This contract was previously extended for a total of three years.

12. Consider Authorizing Issuance of New Contract to Complete Work Initiated by City of Wildomar under Contract #ML18137 (\$50,000 – Install Class II Bicvcle Lane Improvements)

Ravenstein

After previously having been granted extensions totaling 18 months, the City of Wildomar requests MSRC review of a contract replacement request for one of two alternatives which were both denied by the MSRC Contracts Administrator. The City indicates that several staff transitions necessitated the outsourcing of design for this project, thereby delaying progress. MSRC Contracts Administrator recommends that a new contract be executed to complete the project, should the MSRC wish to grant the City's request.

# FYs 2021-24 WORK PROGRAM

13. Consider Modified/Corrected Award to City of South Pasadena under the Transformative Transportation Strategies Program

Ravenstein

As an element of their FYs 2021-24 Work Program, the MSRC previously awarded \$499,789 to the City of South Pasadena for their Police Patrol Vehicle Electrification Program as part of the MSRC's Transformative Transportation Strategies Program. Among other elements, the project was described as including the installation of two new dual-port, police-dedicated Level 3 chargers and one additional Level 3 charger which would be available to the public, when the description of the Level 3 infrastructure elements of the project should have specified the installation of one new dual-port Level 3 charger which is for public safety use. (Level 2 chargers are part of the project and will remain unchanged. A significant portion of those Level 2 chargers will be available to the public.) MSRC staff recommends modifying the description of the Level 3 portions of the project to reflect the installation of one dual-port, limited-access Level 3 charger.

Emission Goods Movement Infrastructure and Consider Possible

Application(s) for U.S. Department of Transportation ("DOT") Funding In August 2022, the MSRC approved the release of a Request for Information (RFI) for publicly accessible infrastructure to support zero emission goods movement vehicles. The MSRC identified up to \$50,000,000 for this effort. The RFI had a submittal deadline of November 30, 2022. An update concerning the ongoing evaluation process will be provided. In addition, an opportunity to seek funding from U.S. DOT's charging and fueling discretionary grant program (including possibly for items submitted in response to the RFI) will be discussed and considered. (*No written material*)

One (1) Final Report was submitted for MSRC-TAC review and approval:

• Capistrano Unified School District, Contract #MS18108A (\$111,7500 - Expansion of Compressed Natural Gas Fueling Infrastructure

A summary of the Final Report is attached. MSRC staff has reviewed this Final Report and recommends approval.

### PROJECT DESCRIPTION

The purpose of the project was to design and install an additional 20 compressed natural gas (CNG) slow-fill fueling posts, rated at 3,600 psi, to the original two compressors/20 slow-fill fueling post station. The project was completed by August, 2021 and became operational in September, 2021.

### STATION UTILIZATION

The Capistrano Unified School District has a total of twenty (20) CNG school buses. Table 1, below, shows the CNG utilization during a six-month data collection period commencing August 2019 and ending January 2020.

### **Contract Execution Status**

### 2018-21 Work Program

On December 6, 2019, the SCAQMD Governing Board approved an award under the Major Event Center Transportation Program. This contract is executed.

On September 4, 2020, the SCAQMD Governing Board approved an award under the Last Mile component of the MSRC's Regional Goods Movement Program. This contract is executed.

On April 2, 2021, the SCAQMD Governing Board approved five awards under the Zero and Near-Zero Emission Cargo Handling Equipment at Warehouse, Distribution and Intermodal Facilities in Riverside and San Bernardino Counties Program and ten awards under the Zero and Near-Zero Emission Trucking to Warehouse, Distribution and Intermodal Facilities in Riverside and San Bernardino Counties Program. These contracts are executed.

On June 4, 2021, the SCAQMD Governing Board approved an award under the Major Event Center Transportation Program. This award has been declined.

### 2021-24 Work Program

Contract Term: September 22, 2021 to May 21, 2027

Current Request: Modified scope and eight-month term extension

Previous Requests: None

<u>Project Description:</u> The MSRC awarded TTSI \$1,500,000 under the FYs 2018-21 On-Road Inland Ports Program to procure and deploy 15 Freightliner near-zero emission semi-tractors equipped with engines meeting the 0.02 g/bhp-hr NOx standard. 10 Volvo and 5 Mack near-zero emission semi-tractors have been deployed and nothing has been paid to date.

<u>Contract Request:</u> TTSI indicates that because the Freightliner trucks were not going to be available in a timely manner, they placed orders for 10 Volvo VNL64T300 and 5 Mack Anthem 64T trucks instead. These vehicles, equipped with Cummins ISX12N 400 engines, meet the NOx standard specified in the contract and there is no difference in the emission benefits to be expected from the project. As specified in Contract #MS21015, the MSRC's share of actual vehicle costs will not exceed 47%.

Even with the change of vendors, TTSI experienced delays in deliveries due to Volvo and Mack factory delays. Eventually, the final truck was placed in operation the week of January 2, 2023. TTSI requests that their contract term be extended to January 2, 2028 to allow for fulfillment of the five-year operational period—approximately an eight-month term extension.

<u>Recommendations:</u> The MSRC Contracts Administrator recommends approval because the trucks are already in operation and the substitution of vendors has no impact on emissions.

This letter is in reference to MSCR Contract Number MS21015. **Premium Transportation Services, Inc. dba Total Transportation Services (TTSI)** are seeking an extension to the start of this contract that was scheduled to commence five months after the contract was executed on 09/22/2021.

Our request to seek an extension to the start of this contract is due to the delay in receiving the trucks prior to the commencement date of the contract. We would like to extend the contract to January 2, 2028.

As per the contract agreement, we ordered 15, CNG Trucks to be utilized in the Counties of Los Angeles, Orange, Riverside, and San Bernardino to transport freight throughout the region. Due to continuous delays by the factories of Volvo and Mack, we did not receive the first 2 trucks of 15 until the end of July 2022. We did not receive the fifteen trucks until mid-December and were not able to place the truck into operation until the week of January 2, 2023.

5 – 2022 Mack Anthem 64T with the Cummins ISX12N 400 Engines

We currently have all trucks in service and are transporting goods from the Ports of Los Angeles and Long Beach to warehouse and distribution centers throughout the four counties listed above. The City identified an opportunity to complete this project's civil work concurrent with the separate City Hall/Public Library Project. The City Hall/Public Library Project includes a parking lot repaving component that allows for economies of scale in accomplishing the additional paving necessary to create an accessible path of travel to the future EV charging stations and installing the below-ground electrical conduit. Final civil plans have been completed, the City Council has approved completing the civil work concurrent with the City Hall/Public Library Project, and the City Manager has executed the final charge order to do so. It is presently anticipated that the civil work will be completed in January 2023.

4. Reason for Delay - Concise explanation, but with sufficient detail to include parties involved and measures undertaken, if

The City's original plan was to complete this project after first completing the separate City Hall/Public Library Project. The City Hall/Public Library Project has experienced several delays, which have had a cascading effect on this project. Rather than award a construction contract in January 2021, the construction contract was awarded in October 2021.

In an attempt to prevent further delays, the City identified an opportunity to complete this project's civil work concurrent with the City Hall/Public Library Project. With that work nearly complete, it is anticipated that remaining work will be complete this summer with the EV charging stations open to the public in September 2023.

The City has identified a cooperative purchasing contract through which the EV charging equipment would be purchased, which is anticipated to help expedite the procurement process.

5. Consequences of Denial – If extension not approved, what noncancellable expenses would Contractor incur? Any other consequences?

If the extension is not approved, the City would incur costs related to design and civil work (the latter totaling approximately \$43,685). Without the MSRC funding, the City would have insufficient funds to purchase the EV charging equipment and complete the EV charging stations.

Project Title: Future Communities Partnership Program

MSRC Funding: \$2,000,000

Project Term: July 13, 2018 to May 31, 2023 Current Request: Six-month term extension

Previous Requests: Modify one project, modify payment schedule, and one-year term

extension; six-month term extension; reallocation of costs between tasks;

nine-month term extension

<u>Project Description</u>: The MSRC awarded SCAG \$2,000,000 to partner on their broad-based regional program to support city and county agencies in implementing pilot projects that reduce vehicle miles traveled (VMT) from local travel and municipal operations through the use of new technologies and enhanced data analytics. Contract #MS18015 was executed to

effectuate the award, and the MSRC approved the specific list of projects in April 2019. The Glendale, Monrovia, San Bernardino County, and Riverside pilots have been concluded, and \$415,803.97 has been paid to date on this contract.

Previous Requests: 1) SCAG was able to accomplish Task I (Research Promising Practices) and Task II (Selection of Specific Project Elements) at lower costs than anticipated. SCAG requested to reallocate \$50,000 from Task I, \$40,000 from Task II, and \$10,000 from Task IV (Reporting) to Task III (Implementation). At their April 2019 meeting, the MSRC considered and approved these reallocations. 2) Subsequently, in September 2019 SCAG indicated that the initial administrative processes for some communities had taken longer than anticipated. SCAG requested a contract term extension to August 31, 2021 to allow time for appropriate data collection and to align deadlines with their other funding source. This modification was processed administratively. 3) Then in the Fall of 2020, SCAG indicated that the COVID-19 pandemic had significantly delayed implementation of most projects in the program. SCAG requested a one-year term extension to allow partnering agencies the flexibility to compensate for lost time and determine if additional modifications may be necessary to complete project work. In particular, the City of Monrovia had been compelled to develop a new scope of work for their project. SCAG requested approval of the revised project list, substituting the proposed bike share and bike delivery incentive program for the shared ride program in Monrovia. 4) Next, due to the expiration of certain co-funding sources, SCAG requested modifications to the payment schedule, which would result in a net increase in total co-funding. At their December 2020 meeting, the MSRC considered and approved these modifications. 5) Lastly, in March 2022 SCAG indicated that four pilots were expected to be complete by the current deadline, but supply chain pressures and staffing capacity challenges associated with the COVID-19 pandemic had continued to delay the Anaheim, Cerritos, Los Angeles, and Ontario project elements. SCAG requested, and the MSRC approved, a nine-month term extension.

<u>Contract Request:</u> SCAG indicates that the Glendale, Monrovia, San Bernardino County, and Riverside pilots are complete. Meanwhile, the Ontario and Cerritos pilots could benefit tremendously from additional time to finish deliverables and complete project close-out tasks.

The Los Angeles Department of Transportation and Anaheim pilots have encountered more involved issues, however. The Los Angeles pilot was not achieving sufficiently high participation. The project team has developed new strategies, but time is needed to incorporate and implement these strategies. For the Anaheim pilot, the project was structured to use an existing mobile application to connect drivers to underutilized parking, and then connect the passengers to the Center City area via free electric shuttle. The company which created and managed the application was recently dissolved, however. While necessary reconfigurations have been accomplished to allow the pilot to proceed, this delayed the project. Therefore, SCAG requests a six-month term extension to allow them to complete the work.

<u>Recommendations</u>: The MSRC-TAC Scope Changes Subcommittee will review the request and their recommendations will be brought forward at the MSRC-TAC meeting. The MSRC Contracts Administrator recommends approval, contingent on this being the final extension.

The Southern California Association of Governments (SCAG) and the Future Communities Partnership Program (FCPP) would like to officially request a contract extension for Contract No. MS18015D. We are requesting a sixmonth extension to amend the contract timeline, which is currently planned for termination effective May 31, 2023. The FCPP project team is proposing a new termination date effective November 30, 2023 to provide additional time for administrative responsibilities, the completion of the final report, and alignment with SCAG's fiscal quarters.

We have brought attention to previous issues caused by the ongoing pandemic, which impacted data collection and the timing of critical milestones. While some pilots have completed their consultant contracts and move through project close-out, others continue to experience delays. The FCPP project teams have completed four pilots, including Glendale, Monrovia, San Bernardino County, and Riverside, with the Evaluation Consultant and respective SCAG project teams finalizing deliverables and educational materials related to the individual projects. However, the pilots with Ontario, Cerritos, Anaheim, and Los Angeles DOT would benefit tremendously from an additional six months to finish deliverables and complete administrative responsibilities related to project close-out and billing/reimbursements, and the LADOT and Anaheim pilots have unique issues impacting their consultant contract timelines and final deliverables. Without additional time, the overall program may not meet the grant's requirements related to data collection or local match reimbursement, due to these difficulties at the pilot level.

The pilot in Los Angeles has encountered an obstacle with recruiting pilot participants. After exhaustive efforts to enroll and recruit new members to the BlueLA program, participation was still not high enough to provide the substantive dataset needed to meet the FCPP requirements. As such, the project team has developed new strategies to engage and obtain this needed information, but these strategies must be formally amended into existing consultant contracts and require some additional time to pivot and incorporate suggested changes. The LADOT team's proposed changes in scope do not impact the overall pilot intent or deviate from the approved Project Elements, but rather they allow the consultant team to deploy new

techniques and outreach strategies to bolster participation and incorporate additional back-up methods.

The pilot in Anaheim was structured to utilize an existing mobile application to connect drivers to underutilized parking, and once parked, to then connect the passengers from those City-owned parking lots to the "CtyCenter" area via free electric shuttle. The company which created and managed the application, however, was recently dissolved during a company merger and the City had to onboard another consultant to take on both the maintenance/development responsibilities as well as the required reconfigurations/updates for the purposes of the FCPP project. Unfortunately, this change in procurement and application management has impacted the project timeline and temporarily delayed implementation efforts.

The pilots in Cerritos and Ontario also would tremendously benefit from additional time to strengthen data collection and meet anticipated match commitments. Recognizing that capacity constraints have impacted these projects in the past, SCAG has recently dedicated additional staff resources to support a successful conclusion to these pilots and effectively deliver results. If granted a final six-month extension to support these remaining projects, it will help ensure adequate data is captured and program expectations are met, not only for Cerritos and Ontario, but also for LADOT and Anaheim.

We thank you for your continued patience and support on the Future Communities Partnership Program as well as other SCAG initiatives. This program has learned to adjust and adapt alongside the evolution of life during Covid-19 and provided many valuable insights along the way. However, the Traffic Signal Interconnect System which the fiber optic cable was intended to support will still be able to function as originally designed due to a wireless connection. SBCTA requests to remove the requirement to install the fiber optic in this segment, with a corresponding reduction in contract value from \$1,250,000 to \$1,237,500 as part of the FYs 2012-14 Traffic Signal Coordination CTC Partnership Program. As part of considering this request, the MSRC needs to evaluate whether the contingency associated with the previous term

extension has been met.

**RECOMMENDATIONS:** The MSRC-TAC Scope Changes Subcommittee will review the

request and their recommendations will be brought forward at the MSRC-TAC meeting. The MSRC Contracts Administrator recommends, if the MSRC opts to approve SBCTA's requested reduction in scope and value, that language be added making reimbursement contingent upon delivery of a Traffic Signal Interconnect System which is operational for the entire project

Project Title: Implement Various Signal Synchronization Projects

MSRC Funding: \$1,250,000

Contract Term: March 27, 2015 to March 26, 2024

Current Request: Reduced scope and value

Previous Requests: Two-year term extension; two-year term extension; two-year term

extension

<u>Project Description:</u> SBCTA was awarded \$1,250,000 to implement a number of signal synchronization projects in partnership with their member jurisdictions. The Baseline/5<sup>th</sup>/Greenspot, Five Corridors, West Valley TMC, Chino Traffic Control System, and Mt. Vernon/Washington projects have been completed and \$1,023,566.17 has been reimbursed to date.

<u>Previous Requests</u>: SBCTA indicated that for one of the project elements, the Mt. Vernon Avenue/Washington Street project in partnership with the City of Colton, signals at the three of the affected intersections first needed to be modified as part of a separate project not funded by the MSRC. The signal modification project had encountered funding issues. Therefore, SBCTA requested a two-year contract term extension while they worked with Caltrans. The MSRC considered and approved SBCTA's request.

Subsequently, SBCTA indicated that the delays with the Caltrans project in Colton had been even greater than anticipated. SBCTA anticipated that several additional months would be needed to complete this project. However, to minimize the potential for additional requests, SBCTA requested a two-year term extension. The MSRC considered and approved SBCTA's request.

Still later, SBCTA stated that another of their project partners, the City of Yucaipa, had experienced extensive delays involving re-distributed staffing hours and the COVID-19 pandemic's impact on goods and services nationwide. The City's portion of the project involved upgrading signal communications technology along Yucaipa Boulevard by installing interconnect conduit and fiber optic cables. SBCTA represented that the conduit installation had been completed, and the City was currently putting together the construction contract documents to obtain a contractor to complete the final phase of the work. A two-year term extension was requested. The MSRC considered and approved SBCTA's request, with the contingency that SBCTA check in to show progress after one year.

Contract Request: Contract #MS14072 specifies that SBCTA shall partner with the City of Yucaipa to upgrade signal technology by installing along Yucaipa Boulevard: interconnect conduit from 15<sup>th</sup> Street to Hampton Road, and fiber optic cables from Hampton Road to 5<sup>th</sup> Street and then into Yucaipa City Hall. Contrary to what was reported at the time of the last extension, SBCTA now states that the City has not completed all the conduit installation. For the segment of Yucaipa Boulevard between 16<sup>th</sup> Street and 18<sup>th</sup> Street, lack of funding to complete street widening has prevented the conduit installation. Because the conduit has not been installed, it is not possible to install fiber optic cable as specified by the contract. SBCTA indicates, however, that if all the other segments are completed, the Traffic Signal Interconnect System which the fiber optic cable was intended to support will still be able to function as originally designed due to a wireless connection. SBCTA requests to remove the requirement to install the fiber optic in the subject segment, with a corresponding reduction in contract value from \$1,250,000 to \$1,237,500 (as referenced in their letter, reducing from \$90,000 to \$77,500

for this project). The activation of the Traffic Signal Interconnect System is forecasted to occur in September 2023 - within the current contract term.

<u>Fulfilling Contingency:</u> In considering approval of this request, the MSRC is also asked to consider whether SBCTA has fulfilled the requirements of the contingency which was associated with the most recent term extension. The contingency to "show progress" is not necessarily clearcut. By some measures, given that no construction occurred and the City did not even select a construction contractor, it could be argued that no progress has been demonstrated. Alternatively, SBCTA has identified a path forward by which the intent of the project – an operational Traffic Signal Interconnect System - could be fulfilled, with no extension of time, and at a lower cost to MSRC.

<u>Recommendations</u>: The MSRC-TAC Scope Changes Subcommittee will review the request and their recommendations will be brought forward at the MSRC-TAC meeting.

Because the current contract language only requires the installation of the conduit and fiber optic cables to upgrade signal communications technology, the MSRC Contracts Administrator recommends, if the MSRC opts to approve SBCTA's requested reduction in scope and value, that language be added making reimbursement contingent upon delivery of a Traffic Signal Interconnect System which is operational for the entire project area.

SBCTA respectfully requests a scope change to contract MS14072C that removes the requirement to install fiber optic cable between 16<sup>th</sup> Street and 18<sup>th</sup> Street on Yucaipa Boulevard from the scope of work. Conduit installation occurred for the remaining project area when the City performed work on Yucaipa Boulevard Street Widening Project. Since then, the City has not been able to secure funding to complete the widening between 16th Street and 18th Street, therefore the City has not been able to move forward with installation of the conduit needed for the fiber optic cable in this location.

The Interconnect system will be able to function without signal communication disruption, as originally designed, despite the gap in physical connectivity between 16<sup>th</sup> and 18<sup>th</sup> Street, due to a wireless connection that has already been set up at Hampton Road (on the other side of the fiber optic gap). This wireless connection is already linked in to the system at Yucaipa City Hall.

Commensurate with the reduction in scope, SBCTA asks that the grant funding be reduced from \$90,000 with a \$175,100 local match to \$77,500 with a \$150,780.56 local match.

**SYNOPSIS:** RCTC was awarded funding to implement a vanpool incentive

program. RCTC requests two modifications to the Statement of Work: 1) Vanpool is currently defined as "five to fifteen Eligible Commuters commuting on a regular basis...", and RCTC requests to modify the definition to "four to fifteen Eligible Commuters..."; and 2) the contract specifies that vanpool incentives shall not exceed \$400 per vanpool per month, but RCTC desires the latitude to increase incentives up to \$600 per month using non-MSRC funds. Additionally, RCTC is requesting a one-year term extension to maximize and amplify the use of the contract allocation to attract more vanpoolers. This contract was

previously extended a total of two years. This project is part of the

FYs 2016-18 County Transportation Commission Partnership

Program.

**FINANCIAL IMPACT:** If the MSRC denies RCTC's requested modification regarding the

definition of vanpool, some funds previously reimbursed would be

subject to possible payback.

**RECOMMENDATIONS:** The MSRC-TAC Scope Changes Subcommittee will review the

request and their recommendations will be brought forward at the MSRC-TAC meeting. The MSRC Contracts Administrator recommends approval of the requested modifications to the Statement of Work but recommends against granting the

requested term extension. Alternatively, if the MSRC does desire

to grant the extension, the MSRC Contracts Administrator recommends that the contract value be reduced by \$171,500.

**DISCUSSION:** 

Contractor: Riverside County Transportation Commission

Project Title: Implement Vanpool Incentive Program

MSRC Funding: \$1,500,000

Project Term: June 28, 2018 to August 27, 2023

Current Request: Modified Statement of Work and one-year term extension

Previous Requests: Two-year term extension

<u>Project Description</u>: RCTC was awarded \$1,500,000 in January 2018 under the MSRC's FYs 2016-18 County Transportation Commission Partnership Program to implement a vanpool incentive program. The VanClub program launched in May 2018 and \$812,660 has been paid to date, covering the period through September 2022. An additional invoice for October through December 2022, in the amount of \$43,000, is on hold pending the outcome of this item.

<u>Previous Requests</u>: RCTC indicated that the VanClub program had been significantly impacted by COVID-19 and it would take additional time to ramp the program back up. They request a two-year term extension. At their June 2021 meeting, the MSRC considered and approved RCTC's request.

### **Contract Request**

### **Vanpool Definition**

Contract #MS18024 defines "Vanpool" as "five to fifteen Eligible Commuters commuting on a regular basis...". While this is, and was always intended to be, the minimum occupancy for *new* vanpools at time of application, RCTC's program guidelines have allowed ongoing occupancy of 50%, or four commuters for a seven-passenger vehicle. This distinction was not understood by MSRC staff at the time of contract formation and thus not reflected in the contract language. Portions of the payments already made to date have been for ongoing vanpools which have had average occupancy greater than four but less than five commuters. RCTC requests the definition be modified to "four to fifteen Eligible Commuters..." consistent with their guidelines. If the MSRC does not approve this request, portions of earlier payments may need to be paid back.

#### **Vanpool Incentive Amount**

The Contract currently specifies that vanpool incentives shall not exceed \$400 per vanpool per month. RCTC notes that since the inception of the program in 2018, this amount has not changed, but the cost of leased vehicles has increased. Additionally, neighboring vanpool programs have increased their subsidy amounts or are evaluating potential increases. RCTC attests that they will be evaluating the potential of increasing the incentive up to \$600 per vanpool, using other than MSRC funds. If this does occur, it would represent an additional consideration being brought forward by RCTC. While there is no firm commitment, RCTC requests that the language be modified to allow for a higher incentive with a \$400 per month cap on the MSRC funding contribution.

#### **Term Extension**


Lastly, RCTC requests an extension to August 31, 2024—approximately a one-year term extension—to provide additional time to maximize and amplify the benefits of the contract allocation to attract more vanpoolers. RCTC indicates that the delay in expending all the funds is a result of the COVID-19 pandemic, which significantly reduced the number of vanpools enrolled in the program. Recovery was also slower than anticipated. RCTC cites that the

decrease in frequency of days working from home has begun to show an increase in the number of enrolled vanpools. They anticipate that increasing the monthly incentive amount would further boost enrollment.

<u>Recommendations</u>: The MSRC-TAC Scope Changes Subcommittee will review the request and their recommendations will be brought forward at the MSRC-TAC meeting.

The difference in definition between what is required to be deemed vanpool at inception, versus what is required to be considered a vanpool on an ongoing basis, were not clearly understood when the contract was being formulated. Given that RCTC always intended this difference and has been consistently operating the program using this distinction from the outset, the MSRC Contracts Administrator recommends approval of their requested change in the vanpool definition. Likewise, the MSRC Contracts Administrator recommends approval of the requested language clarification to allow a greater per-month incentive, provided that the MSRC contribution remains capped at \$400 per month.

With respect to RCTC's term extension request, the two-year extension previously granted by the MSRC has not proven sufficient for the VanClub program to be able to return to prepandemic participation levels. As indicated by the chart below, invoicing has resumed at about half the level seen pre-pandemic, on a quarterly basis.



While an increase in the maximum per-month vanpool incentive would likely result in some growth in participation, it is difficult to gauge the extent of this. A one-year term extension might not be sufficient to see a significant impact from the change, especially since RCTC does not provide a date certain when such an increase might take effect. Certainly if invoicing remains at current levels the remaining funds would not all be expended, and even if it increases modestly a substantial balance would remain.

In consideration of the above, the MSRC Contracts Administrator recommends against granting the requested term extension. Alternatively, if the MSRC does desire to grant the extension, the MSRC Contracts Administrator recommends that the contract value be reduced by \$171,500 to

\$1,328,500. This would retain sufficient funding in the contract to reimburse quarterly invoices at about 1.5 times the current rate over the extended term.

Riverside County Transportation Commission (RCTC) respectfully requests a modification to contract MS18024 to adjust the following:

- 1. Attachment 1 Statement of Work
  - a. Definition of Vanpool
  - b. Clarification of Vanpool Incentive
- 2. Term of Contract

#### 1. Attachment 1 - Statement of Work

### a. <u>Definition of Vanpool</u>

As currently written, a "Vanpool" is defined as "five to fifteen Eligible Commuters commuting on a regular basis...". However, this definition, specifically the reference to "five", applies to the capacity requirements for the inception of a new vanpool only, as opposed to requirements of an ongoing vanpool. As referenced in the program guidelines, the minimum occupancy at the time of application for a new vanpool is 70%, or five commuters for a 7-passenger vehicle. However, the minimum ongoing occupancy requirement is 50%, or four commuters for a 7-passenger vehicle. As such, RCTC requests the definition of "Vanpool" in the Statement of Work to be updated to "four to fifteen Eligible Commuters commuting on a regular basis...".

### b. <u>Vanpool Incentive</u>

The current minimum requirements listed in the Statement of Work state that "Vanpool incentives shall not exceed \$400 per vanpool per month...". Since inception of the VanClub program, incentives have remained unchanged at \$400 per month. However, the cost of leased vehicles has increased over the years. Additionally, neighboring Vanpool programs have already increased the subsidy amount or are in the process of evaluating an increase to their current subsidy amount. In order to continue to

help keep vanpool an attractive alternative to driving alone and remain consistent with other vanpool programs in the region, RCTC will be evaluating the need to increase the subsidy amount up to \$600 per vanpool per month. While the incentive amount may increase, there is no expectation that MSRC reimburse vanpools beyond the \$400 amount outlined in the Statement of Work. For clarification purposes however, RCTC requests the language under minimum requirements be updated to "Vanpool incentives shall not exceed the RCTC board approved monthly vanpool subsidy amount. Reimbursements by the MSRC shall not exceed \$400 per vanpool per month...".

#### 2. Term of Contract

Contract MS18024 currently expires August 27, 2023. RCTC respectfully requests a no-cost, twelvemonth (12) extension through August 31, 2024. This request is to provide additional time to maximize and amplify the benefits of the contract allocation to attract more vanpoolers. As mentioned in the above requested change to the Statement of Work, RCTC intends to increase the monthly subsidy per vanpool from \$400 to \$600. Other funding sources will be used for the additional subsidy amount, and MSRC funds will continue to subsidize vanpools up to only \$400 per month, per vanpool. The Commission is scheduled to expend the full grant funds by August 31, 2024. At this point in time, RCTC has expended over 57% of the granted funds and anticipates expending the full amount by the date of the extension. The delay in expending the funds is a result of the COVID-19 pandemic, which significantly reduced the number of vanpools that were enrolled in the program, and a slower than anticipated recovery. However, as more employees transition back to working on site and decreasing the frequency of days working from home, the number of enrolled vanpools is beginning to grow.

The requested extension will provide for continued subsidies for eligible vanpools destined for worksites in western Riverside County. Since VanClub's inception, it is estimated that participants who have switched from single occupancy vehicle trips to vanpooling have eliminated more than 5,300 tons of emissions thanks to MSRC funding. Denial of this request may result in RCTC needing to reduce the timeframe that VanClub subsidies are available and potentially causing vanpools to disband and revert to lower density/lower emission reducing carpools or worse, back to single occupancy vehicle arrangements.

Project Title: Install EV Charging Infrastructure

MSRC Funding: \$63,097

Project Term: December 14, 2018 to March 13, 2026

Current Request: Location change and 18-month term extension

Previous Requests: Three-year term extension

<u>Project Description</u>: The MSRC awarded the City \$63,097 to install six Level II publicly accessible EV charging stations. No construction has been completed and nothing has been paid to date on this contract.

<u>Previous Request</u>: The City indicated that from 2019 to early 2021, their Public Works, Engineering and Development Services departments underwent a fluctuation in staffing. Vacant positions critical to progress on the project were not filled until mid-2021. Additionally, the City had determined that costs to install the charging stations would be higher than originally

anticipated. They were in the process of researching additional funding opportunities including those offered by Southern California Edison. The City was confident that the project could be completed and requested a three-year contract term extension to allow them to complete the required operational period. At their February 2022 meeting, the MSRC considered and approved the City's request.

<u>Contract Request</u>: The City and its partners reviewed the tentative locations specified in the contract, and felt that the locations are in too close proximity for optimal utilization. Therefore, the City requests to locate stations at the Yucaipa Performing Arts Center at 12062 California Street rather than the Yucaipa Police Department at 34144 Yucaipa Boulevard. Please note that the provisions of Contract #ML18129 specify that the locations described therein are tentative and the City may notify MSRC staff of location changes. Thus, if no other changes were sought, no MSRC consideration would be required.

The City indicates that the funding priorities of their intended funding partners shifted, forcing them to seek new potential partners and delaying project completion. They are still in the process of trying to obtain additional co-funding. The City requests an 18-month term extension to allow time to complete the installations and fulfill the three-year operational requirement.

MSRC Contracts Administrator Review & Contractor Request for MSRC Review of Denial:In accordance with the MSRC's recently adopted Policy on Contract Modifications, the request was reviewed by the MSRC's Contracts Administrator. The first review is for completeness. Having satisfied those requirements, the request is then checked against a set list of preestablished criteria for denial. The Contracts Administrator denied the City's request because it fell into the following category: this contract has previously been extended a for total of two years or more, and the current request is for greater than one year.

The purpose of this letter is to respectfully request an extension of time to deliver the City of Yucaipa's (City) MSRC-funded project. Per the email dated February 2, 2023, the expiration date for the subject contract is April 2026. The City of Yucaipa is requesting that this expiration date be extended for an additional eighteen (18) months to October 2027.

In December 2018, the City requested a three (3) year extension for City's Clean Transportation Funding project. In February 2019, that request was granted, and the End of Three-Year Operational Availability was extended to April of 2026.

For FY 21/22, City Council has placed the alternative fueling/power projects on its list of priorities. This includes the research, development, and implementation of EV programs. Due to this priority, and the increased staff levels, the City has focused on the EV Charging Station Infrastructure at various City locations. The City is in the process of re-evaluating the EV charging station locations and quantities at each location (there will still be a total of six (6) electric vehicle (EV) Charging Stations) set forth by the funding guidelines.

Since FY 21/22, the City has been communicating and collaborating with numerous partners for providing hardware, installation, and monitoring of the proposed EV Charging Stations. During this process, the funding requirements of the partners have shifted away from the goals of the City (for example – installing only Level 1 charging stations). This change has required the City to reach out to new potential partners in order to secure the necessary available funding to install the EV Charging Stations.

At the time of the shift, the City was in the preliminary design of the EV Charging Stations at the three (3) designated locations set forth by the funding guidelines. During the preliminary design, staff looked at other City facilities that would better suit EV Charging Stations. The funding guidelines state that EV Charging Stations would be installed at the locations listed below:

- Yucaipa City Hall, 34272 Yucaipa Boulevard
- Yucaipa Community Center, 34900 Oak Glen Road
- Yucaipa Police Department, 34144 Yucaipa Boulevard

The proposed locations of the EV Charging Stations at Yucaipa City Hall and the Yucaipa Police Department facilities are approximately 140 feet apart. When working on the preliminary design,

staff and City partners felt that the locations are too close in proximity and investigated a third alternate City location to install the EV Charging Stations.

This investigation led to the Yucaipa Performing Arts Center (YPAC) (12062 California Street). The YPAC is located in the center of the City's Historic Uptown District and would be an attractive addition to the City's growing Uptown District.

In addition to the timeline extension, the City is also requesting that EV Charging Stations located to be installed at the Yucaipa Police Station, be moved to the YPAC. The number of EV Charging Stations will remain the same.

The City is confident that construction of the EV Charging Stations can be completed by the March 2024 timeframe and the extension will allow the City to complete the three (3) year operation requirement.

This project is part of the FYs 2016-18 Local Government Partnership Program.

FINANCIAL IMPACT: Nothing has been paid to date under #ML18137. \$50,000 remains

committed towards the bicycle lane improvements, and will become available to fund a replacement contract if so authorized

by the MSRC.

**RECOMMENDATIONS:** This request was previously denied by the MSRC Contracts

Administrator.

**DISCUSSION:** The City was originally awarded \$50,000 under the MSRC's FYs 2016-18 Local Government Partnership Program to install Class II bicycle lane improvements along

approximately 1.5 miles of roadway. Preliminary engineering has been completed and nothing

has been paid to date on this contract.

<u>Previous Requests:</u> The City indicated that they needed additional time to inform the public of the completed project, which could possibly affect the data in the post-completion bicycle counts. They requested a six-month contract term extension, which was processed administratively. Subsequently, the City indicated that it might be necessary to relocated some existing utility poles. To accommodate this and any other unforeseen delays, the City requested, and the MSRC approved, a one-year term extension.

<u>Contract Request</u>: The City now indicates that they had intended to design this project inhouse. However, several staff transitions have made in-house design no longer a viable option. The City requested an extension for one of two alternatives:

- 1. A 24-month extension to complete the full scope of work, which would represent a slight expansion including all of the original scope as well as adjacent parts of Clinton Keith Rd. that are missing bike lanes; or
- 2. A 12-month extension to complete a shorter segment of the project—specifically, to replace approximately 20 grate inlets across the Clinton Keith Rd./Interstate 15 bridge with bicycle-compliant grates and to restripe the bridge to provide adequate width for bike lanes. The City estimates the total cost of this reduced scope at \$50,000, and understands that the corresponding contract value would be \$25,000. The remaining \$25,000 would revert to the AB 2766 Discretionary Fund.

MSRC Contracts Administrator Review & Contractor Request for MSRC Review of Denial:In accordance with the MSRC's recently adopted Policy on Contract Modifications, the request was reviewed by the MSRC's Contracts Administrator. The first review is for completeness. Having satisfied those requirements, the request is then checked against a set list of preestablished criteria for denial. The Contracts Administrator denied the City's request for both alternatives because they fell into the following category: contract has previously been extended for a total of one year or more, no work has been completed, and there are no noncancellable expenses.

Also as established by the Policy on Contract Modifications, the Contractor has the right to request MSRC review if their extension request is denied by the Contracts Administrator. The City has exercised this option.

During the process of MSRC staff working with the City to obtain further details and clarification regarding their proposed alternatives and current project status, Contract #ML18137 lapsed. MSRC staff are still attempting to obtain additional details on the proposed alternative.

<u>Recommendations</u>: The MSRC Contracts Administrator recommends that a new contract be executed to complete the project, should the MSRC wish to grant the City's request. Nothing has been paid to date on the previous contract, so the new contract value would be either \$50,000 or \$25,000 depending upon the alternative selected.

## Alternative Extension Request to Expedite Project Expenditures

The Project limits, as originally approved by Attachment 1 of Contract ML18137, are from George Ave. (now Wildomar Trail) to the eastern City limits. As part of the Project design, the Project limits have expanded about 1750 feet to the west and 600 feet to the east to incorporate adjacent parts of Clinton Keith Rd. that are missing bike lanes. The new Project limits are from the I-15 Southbound Ramps at Clinton Keith Rd. east to Copper Craft Rd. To the west, the added scope proposes to replace approximately 20 grate inlets across the Clinton Keith Rd./I-15 bridge with bicycle compliant grates. In addition, restriping of the bridge is required to provide adequate width for new bike lanes. Currently, there are Class II bike lanes on either side of the bridge, but the bridge does not include bike lanes. An exhibit of the revised limits and updated scope of work is included as an attachment to this request. The City estimates that the cost of the bridge improvements alone, apart from the rest of the widening project, would be approximately \$50,000. An encroachment permit from Caltrans would be required to complete these improvements, but design is complete and the City could proceed with these improvements sooner than the overall project schedule. If allowed by the MSRC, the City can expend the grant funds on these bicycle improvements alone and accelerate the expenditure of the grant funds. Below is a potential schedule to complete this work:



**SYNOPSIS:** As an element of their FYs 2021-24 Work Program, the MSRC previously

awarded \$499,789 to the City of South Pasadena for their Police Patrol Vehicle Electrification Program as part of the MSRC's Transformative Transportation Strategies Program. Among other elements, the project was described as including the installation of two new dual-port, police-dedicated Level 3 chargers and one additional Level 3 charger which would be available to the public, when the description of the Level 3 infrastructure elements of the project should have specified the installation of one new dual-port Level 3 charger which is for public safety use. Level 2 chargers are part of the project and will remain unchanged. A significant portion of those Level 2 chargers will be available to the

public.

**RECOMMENDATION:** MSRC staff recommends modifying the description of the Level 3

portions of the project to reflect the installation of one dual-port, limited-

access Level 3 charger.

FISCAL IMPACT: None

As an element of their FYs 2021-24 Work Program, the MSRC previously awarded \$499,789 to the City of South Pasadena for their Police Patrol Vehicle Electrification Program as part of the MSRC's Transformative Transportation Strategies Program. Project elements for which the MSRC would provide co-funding were described as follows:

- Procurement of ten (10) Tesla Model Y patrol vehicles through a 60-month lease arrangement;
- Installation of seven (7) police-dedicated dual port Level 2 chargers;
- Installation of two (2) police-dedicated single port Level 2 chargers;
- Installation of two (2) dual port emergency response vehicle Level 3 chargers.

In addition, the City and its partners are fully funding a number of other non-patrol project elements. These were described as follows:

"Ten (10) Tesla Model 3 non-patrol police and detective vehicles, six (6) additional dual port Level 2 chargers, two (2) single port [Level 2] chargers, and one (1) Level 3 dual port fast charger. This City-funded EVSE will be publicly accessible. South Pasadena will co-fund the upfitting of the electric vehicles with police patrol vehicle equipment."

Clarification has been obtained that the description of the Level 3 infrastructure elements of the project should have specified the installation of <u>one</u> new dual-port Level 3 charger which is for public safety use. It is worthy of note that there are existing, publicly accessible Level 3 chargers in the parking lot east of Mound Avenue, across from the Civic Center, which are operated by EVGo.

MSRC staff recommends modifying the description to reflect the installation of one dual-port, limited-access Level 3 charger rather than the installation of two dual-port, limited-access and one dual-port, public-access Level 3 chargers.
