ACTION CALENDAR

 Consider 18-Month Term Extension by Air Products and Chemicals Inc., Contract #MS18182 (\$1,000,000 – Install Hydrogen Refueling Station in Paramount) Ravenstein

The proposed hydrogen refueling station is part of a larger project at the site to produce transportation products, including sustainable aviation fuel (SAF). This larger project is still undergoing replanning efforts, and the project team has asked that any other activity, including the permitting for the hydrogen station, be delayed until the SAF project is finalized. Therefore, Air Products is requesting an 18-month term extension. This contract has not previously been extended. The MSRC Contracts Administrator recommends approval.

 Consider Modified Statement of Work and Payment Schedule by City of Yucaipa, Contract #ML18129 (\$63,097 – Install EV Charging Infrastructure) Ravenstein

The City has contracted with OBE Power (OBE) to design, install, and maintain the charging stations at City facilities. Under this agreement, OBE will own the stations for at least 10 years. The City requests to modify #ML18129 to reflect this ownership arrangement, with the understanding that the City would still be responsible for meeting the contract's requirements. Additionally, the City requests to increase the number of Level II public-access stations from six (6) to twelve (12), at no additional cost to the MSRC. While OBE will cover the cost of the charging equipment itself and direct installation costs, MSRC funding would go towards necessary civil construction work including addressing accessibility requirements. The MSRC Contracts Administrator recommends approval.

 Consider 18-Month Term Extension by Ryder Integrated Logistics, Inc., Contract #MS21016 (\$3,169,746 - Procure Two Integrated Power Centers and Four Mega Chargers) Ravenstein

Contract #MS21016 provides co-funding for electric vehicle service equipment. While the contract will not reimburse for the electric vehicles which use the equipment, their procurement and use is an integral part of the total project and a contract requirement. Ryder has indicated that their electric tractor manufacturer partner is not yet in full production, and production and delivery dates are uncertain. Ryder requests an 18-month term extension. They commit that if the delivery date is not clear by April 1, 2025, they will move to expedite the process and request any necessary changes. This contract has not previously been extended. The MSRC Contracts Administrator recommends approval with the condition that Ryder will submit either a firm delivery date or a modification request by April 1, 2025.

Ravenstein

 Consider Modified Scope and Reallocation of Funding Between Projects by Southern California Association of Governments (SCAG), Contract #MS21005 (\$16,751,000 – Implement Last Mile Freight Program)

At their April 2024 meeting, the MSRC approved reserving \$1,417,043 from withdrawn and discontinued projects for a reallocation request to be brought forward by SCAG at a future meeting, with the condition that SCAG submit such request by April 22, 2024. SCAG submitted a request by the deadline and recommends that this \$1,417,043 be reallocated to New Bern Transport Corporation. With this additional funding, New Bern would expand their existing project in Buena Park, procuring an additional 10 Tesla Class 8 zero-emission tractors.

Additionally, Project Participant Zeem Solutions has not been able to secure the specified Santa Ana site. Zeem now seeks to include their Long Beach depot instead of the Santa Ana site.

Currently, regarding Zeem, SCAG's contract specifies:

- 72 zero-emission electric vehicles;
- 1 mobile charger covering two Inglewood sites; and
- 23 fast-chargers and 12 Level 2 chargers in Santa Ana.

SCAG requests to modify its contract for the Zeem project as follows:

- 42 zero-emission electric vehicles; and
- 42 dual port fast chargers in Long Beach.

Zeem also seeks to expand the vehicle manufacturers deemed eligible to include all HVIP-eligible zero emission Class 4 and higher trucks. SCAG requests approval of this modified scope. The MSRC Contracts Administrator recommends approval of the reallocation re New Bern and will provide options regarding modification of the Zeem project.
